Budget for Vocational Training Program 2019-20

A proposal on vocational training for the FY 2018-19 was earlier submitted to Asha for Education. The budgetary estimate in that proposal was slated at Rs. 20,07,000/-, out of which Rs, 20,00,000/- was thankfully received and till date 13,21,047/- has been utilized. The training program for the FY 2018-19 is in operation, and running successfully. We are hereby submitting a revised proposal for the year 2019-20. This year, we have increased the budgetary share for rural trainee conveyance and food amount, because a lot of newly enrolled trainees in our institute are from remote locations, who need support with food and conveyance. Also, the RKMA Sargachi vocational training program has succeeded because of constant experimentation with various ideas, which have later grown into full fledged training programs. It has become important to allocate some funds to meet expenses due to these endeavors. The contingency fund item has been incorporated in order to take care of the unexpected expenses along with expenses required for experimentation. The program on solar devices, which started last year, will continue.

Hence, the budget of 2019-20 is divided into two parts, as follows:
