### 1) Objectives

To continuesupporting twobridging / coaching centres for 180 children inKumargram, Alipurduar District, under the NabaDiganta Project for the period from 1<sup>st</sup>April 2020 to 31<sup>st</sup> March 2021.

#### 2) Commitments of Asha Zurich

In Asha Zurich's June-2020 monthly meeting it was resolved to continue supporting the NabaDiganta Projectwitha capacity of 180 children. Asha Zurich will fund the running costs of **INR12,36,000**for the year 2020-21as per the budget in Appendix I.

The Asha Zurich committee further resolved to transfer the above amount in the year 2020-21 inoneor two installments.

### 3) Commitments of Sabuj Sangha

- To inculcate the habit of going to school regularly in children
- To prepare children for government school
- To provide back-up classes for children who have joined government school
- To recruit enough teachers to bring down the teacher/student ratio to 1/25
- To monitor the quality of the teachers
- To provide school books and school bags to the children
- To provide a morning tiffin to the children
- To carry out monthly health checks
- To provide school uniforms
- To maintain the centre and if possible install sanitation facilities





- To identify students with potential and recommend them to Asha Zurich for scholarships in respect of their secondary education
- To allow members of Asha Zurich or third parties delegated by Asha Zurich to conduct project site visits
- To provide the following reports to Asha Zurich one month before the instalments are due.
  - Report 1: Education Component (student's grades/performance, goals achieved, targets planned, number of drop-out students, number of teachers changed/resigned, students who are recommended for scholarships, details of students who joined government school)
  - Report 2: Expenditure statement (expenses incurred and foreseen with details, receipts, etc. attested by the accountant)

#### 4) General Terms

- This MoU shall be suspended if either of the signing parties fails to honour any of their above mentioned commitments.
- This MoUis valid only for the above-mentioned project.
- Any further collaboration between Asha Zurich and Sabuj Sangha will require a new MoU to be signed separately.

Asha Zurich greatly appreciates the noble work being done by Sabuj Sangha and wishes to stay updated on their progress and work in future.
