1) Objectives

To continue supporting Abasik Sishu Sramik Vidyalaya (residential school for prevention of child labour) for approx. 35 children in the South 24 Parganas District, Bengal, West India under the Natun Aalo Project.

2) Commitments of Asha Zurich

- During the meeting held on 6th of July 2018 Asha Zurich Committee has agreed to support the Abasik Sishu Sramik Vidyalaya residential school and cover its running costs of INR 12,93,100.00 for the year 2018/2019.
- The full budget covered by Asha Zurich for the Abasik Sishu Sramik Vidyalaya school's year 2018/2019 is detailed in Appendix 1.
- The Asha Zurich Committee decided that the proposed additional fixed costs of INR 2,50,000.00 dedicated to construction of Abasik Sishu Sramik Vidyalaya children's playground and the computer laboratory will not be granted within this agreement. More detailed discussions about this support are planned.
- Asha Zurich committee has agreed that the amount of INR 12,93,100.00 for the year 2018/2019 will be sent in two instalments:
 - o First instalment of INR 6,46,550 in August 2018
 - Second instalment of INR 6,46,550 in November 2018





3) Commitments of Sabuj Sangha's

- To provide residence and meals to the children in Abasik Sishu Sramik Vidyalaya school.
- To prepare children for formal school or vocational education.
- To monitor the quality of the teachers.
- To provide school books and educational materials to the children.
- To provide toiletries.
- To provide medical support.
- To provide casual and winter dress.
- To provide school uniforms.
- To organize one exposure visit for the children in the school year 2018/2019.
- To maintain all areas of the residential school.
- To identify students with potential and recommend them to Asha Zurich for scholarships in respect of their secondary education.
- To allow members of Asha Zurich or third parties delegated by Asha Zurich to conduct project site visits.
- To provide two reports to the Asha Zurich Project Coordinator the latest on the following dates:
 - o Report I: 15th October 2018
 - o Report II: 15th March 2019

Each of the two reports should consist of two separate parts including the following elements:

o Part 1: Educational progress

- O List with the names of enrolled pupils in Abasik Sishu Sramik Vidyalaya school with their class assignment.
- O List with the names of teachers, subject taught, number of years working at Abasik Sishu Sramik Vidyalaya school.
- o Information about any resignations and/or new enrolments of the pupils since last time reported to Asha Zurich.
- o Information about any personal changes to employed staff members including teachers, superintendent, house mother, cook, cook's helper since last time reported to Asha Zurich.
- O Description of the influence of the granted funding on children's education, health, and well-being.
- o Potential recommendation of the pupils for Asha scholarships.
- o Information about the pupils who joint the governmental school.
- o General description of the goals achieved by the school since last time reported.
- Goals planned for the next 6 months concerning the school's educational as well as organizational aspects.
- o Potential problems about which Asha Zurich should be informed.

o Part 2: Expenditure statement

- Detailed list of the school's expenses since last report including receipts attested by the accountant.
- o Tentative list of expenses foreseen for the next 6 month.



4) General Terms

- This MoU shall be suspended if either of the signing parties fails to honour any of their above mentioned commitments.
- This MoU is valid only for the above-mentioned project.
- Any further collaboration between Asha Zurich and Sabuj Sangha will require a new MoU to be signed separately.

Asha Zurich greatly appreciates the noble work being done by Sabuj Sangha and wishes to stay updated on their progress and work in future.
