



## Memorandum of Understanding (“MoU”)

### 1) Objectives

To yearly support Gourav Halder (hereinafter referred to as “Beneficiary”), graduate of Natun Aalo (residential school for prevention of child labour, South 24 Parganas District, Bengal, West India), with Asha for Education Zurich Scholarship during his education on grade IX level in academic year 2019. The funding is granted for one year in period February 2019 – January 2020.

### 2) Commitments of Asha Zurich

- During the meeting held on 7<sup>th</sup> of December 2018 Asha Zurich Committee has agreed to support Gourav Halder in continuing his education on grade IX, after graduating from Natun Aalo residential school, and award him the Asha for Education Zurich Scholarship in amount of INR 35,400.00 covering the costs of his education in period academic year 2019.
- The full budget covered by Asha Zurich for Beneficiary education for period February 2019 – January 2020 is detailed in Appendix 1.
- Asha for Education Zurich committee has agreed that the amount of INR 35,400.00 will be sent in three instalments:
  - o First instalment of INR 5,900.00 in March 2019
  - o Second instalment of INR 17,700.00 in April 2019
  - o Third instalment of INR 11,800.00 in September 2019





### 3) Commitments of Sabuj Sangha

- To support and monitor the progress of Beneficiary during his education on grade IX.
- To ensure that Beneficiary is provided with daily meals.
- To ensure that Beneficiary has permanent accommodation during his education.
- To ensure that Beneficiary is provided with educational materials.
- To ensure that Beneficiary has paid after-school tuition.
- To provide Asha for Education Zurich the records of the school exams results of Beneficiary latest on the following dates:
  - o 1<sup>st</sup> term results: 30<sup>th</sup> April 2019
  - o 2<sup>nd</sup> term results: 15<sup>th</sup> September 2019
  - o Final term results: 15<sup>th</sup> December 2019


The record of the results should consist of a list of the subjects and the number of points achieved by Beneficiary approved by the school, or Natun Aalo staff members.

### 4) General Terms

- This MoU shall be suspended if either of the signing parties fails to honour any of their above mentioned commitments.
- This MoU is valid only for the above-mentioned project.
- Any further collaboration between Asha Zurich and Sabuj Sangha will require a new MoU to be signed separately.
- This MoU shall be suspended if Gourav Halder terminates his education during academic year 2019 (January – November), resulting in cancellation of Asha for Education Scholarship and termination of the support, effective immediately.
- The scholarship may be terminated by Asha for Education Zurich committee, effective immediately, if behaviour of beneficiary or situation in education center where he learns rise strong ethical concerns.

Asha Zurich greatly appreciates the noble work being done by Sabuj Sangha and wishes to stay updated on their progress and work in future.
