Dear Asha for Education – Boston Chapter,

As Director of Kalkeri Sangeet Vidyalaya (KSV) I would like to present to you our proposal and request for financial assistance for the organization. This is the third year that KSV is applying for funds from Asha for Education – Boston Chapter.

Our application for financial assistance is for 7,00,000 INR (9,715 USD). This amount is a 1,50,000 increase on last year's contribution from Asha, and this is due to the fact that we still have a shortfall of funds. We believe our proposal is worthy of your consideration. KSV is a special school because as well as academic education, the school offers its 220 students a thorough training in Hindustani classical music, and/or Kathak dance. We view this as an empowerment tool for these socially and economically marginalized young people which offer them the opportunity for a better and brighter future.

In addition to the academic and performing arts education, KSV offers board, lodging and health care to its students – all free of cost. Since the inception of the organization in November 2002, we have seen a remarkable transformation in the students as they have progressed through school, college and university. These young adults, with great prospects, are now engaged in respectable and dignified employment. As we all know, education is the key to ending the cycle of poverty. Today we are asking for your assistance in order to conduct operations for the school for the academic year 2019-20. This much needed funding will enable KSV to continue to provide and improve upon the services we currently offer to these deserving children within the areas of academic education, music education and healthcare.

We very much hope that we will receive a positive response to our appeal. We are looking forward to hearing from you, and in the future entering into a long-term professional working relationship with the Boston Chapter of Asha for Education.
