1. Is the project/NGO being currently supported by any chapter of Asha for Education? Has the project/NGO worked with any Asha chapter in the past, including Asha-Austin? If so, please describe the details of funding, line-items supported, funding amounts, and duration.

Asha India trust is supported by several chapters of Asha for Education. Asha Chennai is a chapter of Asha for Education as well. We will be the ones implementing the project.

2. Has the project/NGO applied to any other nonprofit, organization, corporation, individual etc or any other Asha chapter, for funding of this proposal and budget? If yes, please provide more details. Kindly let us know the % of funding towards operational budget, funding amount, duration of funding and type of funding, for 2019-20.

Note: Types of funding are of the following – one-time/ recurring, restricted/non-restricted, etc. One-time grant is usually for infrastructure. Recurring is usually for annual operating expenses, for e.g. salaries of teachers/ staff. Restricted is for specific line-items for the funding year. Non-restricted is for general funds of the NGO with no restriction on the line-item or the year to be utilized.

Asha Chennai has applied for funding for the same project to Asha Silicon Valley as well. We have not approached anyone else. The NGO in this case Asha trust has applied for funding to lot of organisations for lot of different projects. Cant possibly list them here.

3. Has the project/NGO been actively pursuing CSR funding from corporate companies around the region? If not, why not. If yes, please let us know the efforts and outcomes.

Asha Chennai gets most of its funding from CSR donations. In particular we get more than one Crore a year from Hyundai Glovis and last year we received Rs 15 Lakhs from Trimble (and hope to get more this year).

We haven't approached any CSR partner for this project as this is in a area we are also not completely familiar with. Asha UP has not really been getting any CSR funding to my knowledge. We need to explore this over time.

**4. Has the project/NGO a corpus funds/ endowment initiative? If not, why not?**

Not really. Asha Chennai once again has about 1 year's funding as our balance. We haven't been able to get sufficient non-earmarked donations to be able to setup a corpus.

Asha trust audit for 2018-19 is not yet completed. I did not have the 2017-18 audit with me. I have given the information for just 2016-17 for the Asha trust as a whole.

**6. Why would the project/NGO want to partner with Asha-Austin? How will our funding grant help the organization? Please describe as to how Asha-Austin's funding would make a difference to you.**

Asha Chennai has already been working with government schools in Tamilnadu for several years. Asha Rajatalab has approached us to working with government schools in their area using the same kind of approaches that we have been using here in Chennai. This would be an experimental project and I

believe a great opportunity for Asha to start engaging with the government schooling system in the biggest and one of the poorest states in India.

Asha Chennai does not have enough funds to fund projects other than those we ourselves are running. Therefore we will not be able to execute this without the support of Asha for Education chapters like Austin.

Note:

If partial funding is given, we will scale down the project. i.e. Support fewer schools. So all the line items are similar priority but all the items will scale down if partially supported. So we have given the same ranking “1” for all items.

If the project demonstrates need for higher or lower funds in any particular 6-month cycle, we may be able to make an exception to the above rule on a case by case basis.
