We are able to admit children in the month of June for mainstreaming them in formal education, we are able to get the good relationship with school authority for school enrollment. Teachers are reporting the defaulters and dropouts in the community to teachers of the kaingkarya

How do you think the school has improved in the **last 6 months**?

Slowly we are increasing the student in supportive education s and reducing the number of children in well as transit school children

What are the problems you have faced in the last 6 months?

- The transit school children for referred for hostel came back with out continuing the education. They were unable to adjust with hostel atmosphere for children.
- The fund sanctioned by Asha was released only in the month of June which led to problems like staff not being paid in time, the full fledged feeding programme is changed into supplementary feeding.

How would you rate the overall effectiveness of this project over the **past 6 months**? Children are attending our supportive education classes regularly. There is a change in the attitude among the children about education.
