### **Description: Funding for Kaorakhali Jana Sevashram**

1. Asha (Urbana-Champaign) has decided to support Kaorakhali Jana Sevashram with a grant of \$1,250 (One thousand two hundred and fifty dollars) for the period October 2006 to September 2007.
2. Asha (Urbana-Champaign) would like its funds to be used directly for the education, training or support objectives described in the proposal. The following schools are supported by the funding:
  - a. Kaorakhali North
  - b. Purba Gabtola

The total number of students to be covered by the funds is not to exceed 200 individuals.

3. Funds provided by Asha for Education should be used only for the items listed below. Any change in this budget requires prior approval from Asha for Education.

Teachers Salary	Upto Indian Rs. 13,500.00
Mid-day meal for students	Upto Indian Rs 42,000.00
Educational Material	Upto Indian Rs 5,000

There must be 3 teachers in each school. Each teacher is to be paid Rs750/month.

The cost of the midday meal is not to exceed Rs3.50 per meal.

4. Kaorakhali Jana Sevashram is required to submit at least two complete financial and narrative reports (you are encouraged to include photographs) on the progress of the project.
5. Any Asha volunteers or Asha appointed representatives may visit the project site at any time with or without notice.
6. Termination of contract
  - a. This contract terminates on Sept. 30<sup>th</sup>, 2007.
  - b. If Asha UIUC is not satisfied with the project progress, Asha UIUC will provide Kaorakhali Jana Sevashram 6 months notice. At the end of the 6-month period, if the situation is not resolved to Asha UIUC's satisfaction, Asha UIUC will discontinue funding the Kaorakhali school project.
  - c. If fraudulent activity is detected, Asha UIUC may terminate project funding immediately.
  - d. Upon termination of the contract, any remaining funds in the bank account designated for Asha activities shall be returned to Asha for Education or forwarded to parties designated by Asha for Education.
7. Renewal of contract
  - a. This contract may be renewed upon the mutual agreement of Asha for Education and Kaorakhali Jana Sevashram.
