About Gram Vikas Trust:

"Gram Vikas Trust" came into existence as a result of the motivation and personal initiative of its founder, to better the socio-economic status of the underprivileged population. Hailing from a rural family, Founder was no stranger to hardships. Having overcome economic and social challenges, due to the backing and economic blessings from certain elder society leaders, Founder set out to do his best to make a positive difference in the lives of fellow underprivileged. Concerns of few committed people to secure integrated development through people's participation. The key areas identified for interventions were Child Rights, Education, Health and hygiene, Women empowerment and Sustainable livelihood opportunity. Our efforts resulted in long lasting association with Government and Quasi Government agencies as also the communities and groups with whom we have worked all these years.

We have come a long way after a small beginning in June, 2001 and in a span of 10 eventful years we have implemented a wide variety of projects covering activities like Child Rights for Change, Reproductive Child health care, Quality Education, watershed development, wasteland development, tribal development, low cost sanitation, alternate energy sources, self-help groups, projects for women up-liftmen and employment generated training programmes, etc. In Bharuch and Narmada Districts of Gujarat. While implementing different developmental projects, our thrust has always been to secure peoples participation. At "GVT" we have always believed in the capacities and capabilities of the communities and have always strive to channel hidden and dormant energies of the people for the betterment of the societies at large. Our efforts have always been directed in the direction of creating an environment conducive of giving opportunities to local people to think and act positively. techniques to understand people's viewpoint and develop an appropriate model of development.

To Foster Democratic & Equitable Living Environment, Where all Vulnerable people specially underprivileged, women and children have to access Education, Health, Sustainable Livelihood opportunity and essential infrastructure services irrespective of their economic and social status.

Purpose / Goals:

The main goal of Gram Vikas Trust is to help improve the social and economic conditions of the population in drought prone Bharuch and Narmada districts of Gujarat. They believe that their goal can be achieved mainly through education which creates awareness and enhances self-development, action and empowerment.

Background of Support A Child Programme:

In the fight to end global poverty, education is one of the most powerful tools available. But every day, millions of young people are deprived of the right to learn when the cost of an enrollment fee or a school uniform stands between them and a brighter future. Fortunately, the Support A Child Programme Fund has helped hundreds of high-achieving students pursue the upper primary, high school, higher secondary, graduation /college or vocational training they need to build a more stable future. Upon graduation, most are able to support themselves and their families, as well as pay for their siblings' educations. But each year, the number of students who qualify for scholarships far exceeds the number of awards. And now, the program's primary grant has reached its end. Without a minimum additional support, hundreds of hard-working students will be forced to drop out of school. Most will never return. But with your help, we can keep the Support A Child Program – and the aspirations of its students – alive

About Support A Child program:

The support-a-child program makes it possible for an individual to sponsor the cost of education or total living expenses for one or more underprivileged children in Bharuch district of India. The aim is to support the child financially till he or she completes college or vocational education and is able to support himself or herself. You can become a sponsor for a child in India for as little as \$20/month.

Gram Vikas Trust in project area that targets children who are unable to pursue education due to lack of funds. The sponsor has the opportunity to become a mentor and friend to his sponsored child by writing letters. The sponsor can also arrange a visit with his child through Asha and the Gram Vikas Trust in project area in India.

Modus operandi:

GVT chooses children based on need and merit and provide them with scholarships from Asha for Education's Support a Child program. A committee consisting of the village leader, teachers, school principal and a representative from GVT choose children based on the following for the program:

- ➤ She/he should be from Below Poverty Line Family (BPL) whose income is not more than Rs.27000/- per year.
- The attendance of the children in school should be more than 80 %.
- The students rank is from 1st to 10th in the class.
- The committee will decide the selection of adoption and that is final.

No of Beneficiaries:

Direct beneficiaries: 35 children from disadvantaged backgrounds who are in urgent need and cannot afford their schooling.

Indirect beneficiaries: Their families, in particular their brothers and sisters that also go to school.

There is no caste involved:

Asha for Education has supported GVT and its Support a Child Initiative since 2006. This year there are 35 children who will need ongoing support. Each child is allocated \$240/-per year to meet their education and nutrition needs. Donors can support one or more child/children and their donation can be a one-time or a renewing contribution towards the child/children they choose to sponsor. The progress reports on all of these children

are updated & tracked each year along with an annual site visit conducted by a volunteer to assess & report the effectiveness of this initiative. These updates are then communicated to the donors and also communicated to the chapter volunteers during chapter meetings.

Justification for 35 children

Unique situation of Bharuch District with Special Economic Zone (S.Z.E), and falling within Delhi – Mumbai Industrial Corridor (DMIC), makes it most vulnerable and impacts on its socio economic condition. The study on impact of S.E.Z.1indicates that It just provides jobs for urban skilled and semi-skilled workers. Local community losses their livelihood opportunities and their traditional rural life are disrupted, resulting into drastic fall in incomes and long periods of unemployment, their children dropping out of school and compelled to work as child labor.

The data of Bharuch District shows similar situation with 48% population as marginalized workers and majority working as daily wager. The education data of district shows that transition rate from primary to upper primary is only 86%, with dropout rate of 14%, the transition from Secondary to Higher secondary is only 49%. The lack of higher education and skills also makes them more vulnerable to the exploitation and they are subjected to violence. Further the districtis falls under Category C2 based on HIV Sentinel Surveillance 2004 – 2006.

Gram Vikas Trust is working since 2001 in Bharuch district and as per the need there are more children in need for support. If we can carry out base line survey we will find more than 1000 such children who need such support only in our project area.

Expected outcome:

By providing scholarships, GVT reduces the cost of education to families with many children, enabling parents to send all their children to school. Education will enhance their social standing, economic independence and empower their decision making. Thus they will be able to contribute more in educating the next generation. Scholarship does not pay for all the educational costs of a child. Parents must pay for their children's school fees as a direct responsibility in their child's education. This and the long-term support of GVT –Asha for Education will change the family's and the child's attitudes towards education.

Risk Assessment:

Funding: If the current sponsor decides to stop funding their student(s), Asha for Education - GVT will temporarily sponsor the children while looking for alternative support. This has not happened to us in the past but Asha for Education - GVT is completely capable of finding new sources of funds. Asha for education will not stop sponsorship after three years since we are committed to providing long-term sponsorship to each child.

Monitoring and Reporting:

- Attendance rate (monthly): This reflects a child's effort and helps us follow up if any new crisis threatens to jeopardize his or her education. Children's attendance rates typically improve after they join the programme. Attendance rates normally translate directly into higher levels of school achievement. We look for rates of 99% and above.
- Assessment of school exam results and school reports (twice yearly): We assess school reports, exam results and academic achievements at school. Again, these normally improve once children are enrolled in our scholarship scheme. Vietnamese school reports tend not to be very helpful, therefore we have created our own reports which teachers write for us.
- Prop-out rate (annually): In many areas where we work this figure is around 5%. Among our scholarship recipients we can cut this to less than 1%.
- Attitude survey: When we recruit children, we conduct a brief survey on the attitudes of children and their parents towards education. We repeat this every two years to assess how effective the programme has been in changing the attitudes of the participants.
