Women Empowerment

- Women traditionally do not have much rights in UP whether it is the household or the community
- Organized the women into self-help groups (SHG) to deal with issues common to them. Created about 35 such self-help groups so that they can be financially independent this will enable them be equals in rights and responsibilities
- Organized multiple training sessions for the SHG
 - Explained the basic functioning and importance of SHG's
 - Talk about health issues and various government schemes
- Running one sewing centers for girls
- The struggle to conserve water and the protest against the Coca-cola plant has been led by women groups
- Organized the community marriage program for the last 5 years, which has been very popular and very well supported locally





Community Marriage Program

- Lok Samiti has been organizing a community marriage program for the last 4 years and this was the 5th year.
- It is organized for poor families and for people from socially marginalized groups musahar, dalit, rajbhar.
- This year 46 couples were married. It started with 22 couples in the first year and it has grown over the years. (22,28, 32, 32 and 46)
- Message is to provide an alternative to expensive marriages and to move away from the practice of dowry
- Each family involved is allowed to invite 50 guests







Community Marriage Program

- The whole event was funded by local contributions and food was served to about 6000 people
- Lok Samiti collected Rs 5,06,651 which included cash and gifts. Donation of 400kgs of grains were also received.
- All the newly married couple received gifts like a bicycle, Benarasi saris, utensils, jewellery, watch, clock, etc.
- The event was well attended by the locals and many elected representatives of the area.







NREGA – Gender at Work

- Lok Samiti has been very active over the last few years working to make sure the provision of NREGA (National Rural Employment Guarantee Act) are implemented well.
- Over the last year, Lok Samiti has teamed up with Gender at Work (GAW) to study and help dalit women to get more benefits from NREGA. They are looking into how NREGA can help bring about gender equality amongst dalits.

NREGA – Gender at Work

- Phase 2 included an awareness program to make the women, especially dalit women, aware of their rights. GAW first trained the field workers to understand gender issues some of the issues are difficult to understand because they are socially ingrained in the lives of the people. They organized a training for dalit women to use NREGA for economic and gender benefits.
- Phase 3 is to make sure the benefits reach the dalit women and see how it impacts their lives and gender equality
- Phase 4 would be to have a dialogue with the government explaining the whole project (18 months), the condition at the start of the program and how it benefitted the community. This could be used to spread it to other villages and communities.





NREGA - Survey of dalits

- Musahar is one of the most discriminated communities considered the dalits among dalits.
- Lok Samiti did a survey of 700 musahar and dalit families in the 30 villages where they work. The results of the survey were published and distributed to different government bodies.
- The Project Director for the area, came across the report and he sent out an order to the different officials to make sure that these families received benefits under NREGA and other schemes and to make sure that their condition improved.
- Govt has now started issuing job cards and giving out work to the families in different villages.
