- a. Integrated development of children to combat poverty and injustice.
- b. To stop school dropout.
- c. To stop early marriage of girl child.

There are always pressures from Govt. to defunct the schools run by Non Governmental Agencies which is confusing for poor, ignorant rural people. There are always chances school dropouts of rural poor children. Hence we are trying our best to prevent this dropout through this education centre.

**Description of current school facilities (building, equipment etc)**

- 1) One building (under construction).
- 2) Board (7 nos.), Wall Maps, Projector, Books, Furniture.
- 3) Play materials.
- 4) Music materials.

**How do you need to improve these facilities?**

We need (1) 100 nos. of high and low benches for sitting of the students, (2) to distribute snacks and fruits twice a week (when they will stay after school hours) for extracurricular activities, (3) some tree plantation required at the campus which will be done by the students, (4) play ground should be improved.

**How do you think the school has improved in the last year?**

- 1) Teachers are very active to improve education of the students.

- 2) Student – Teacher’s relation are very cordial.
- 3) Concern of guardian’s has developed for education of their children.
- 4) Children are also realizing the importance of education.

**What are the problems you have faced in the last year?**

- 1) Sudden changes of Govt. policies regarding school admission.
- 2) Sudden and abrupt decisions of Government regarding school affiliation.
- 3) Early marriage of Girl Children.
- 4) Lack of friendly atmosphere for students to study at home.

**How would you rate the overall effectiveness of this project over the past year?**

- 1) Student’s attentiveness – 80%
