Given below point wise answers to your questions:-

1. Can you provide the results from the home testing? How are the children doing on these tests compared to when they take them in the classrooms?

Yes, we are providing marks for these home based tests. Our teachers are collecting the answer sheets from the parents, doing assessment, putting comments on the sheets and providing scores for every child. These examined answer-sheets are being returned to the parents during the parent-teacher meeting at the doorstep of each student thrice a month. Since we are taking three tests on every ten-days, we are preparing monthly score sheets by entering scores in three columns and calculating the monthly average score for each month. We have initiated this pattern of study in the last month (Sep. 2020) and are in the process of developing this new system effectively. Only after doing that properly, we will be able to gauge as to how the children are doing on these home based tests, compared to the results of classrooms tests, taken previously. However, the overall reflection of the teachers in this regard during the last teachers-team meeting has been satisfactory.

2. Has SWIRD considered using soap or gloves instead of hand sanitizers? Based on recent data, COVID is not transferred via touching so we believe hand sanitizers will not be as effective. Soap and gloves are better alternatives and cheaper than hand sanitizers.

Yes, we are considering a revision in our budget in this regard. Nowadays, it has become a habit for most of the community people to sanitize hands, either by using soaps or by sanitizers. Soaps, sanitizers, disinfectants etc. have become the part of day-to-day life for everyone. We hope that our teachers are sensitized enough to take proper precautions during their visits to the children's residences and there is no need to bear any extra cost from our project budget for this head. Our teachers won't mind to bear this cost personally. Therefore we are not asking for hand sanitizers or soaps for teachers and would like to delete this line-item from our budget.

3.Are the landlords in dire need of money? If SWIRD does not pay the landlords, will it hurt the relationship?

We mentioned in our previous mail that some landlords started grumbling about their financial loss. Few of them were looking for new tenants. Few of them opted for a partial rent to give us possession, which we felt justified and SWIRD decided to give 25% of the monthly rent of 10 school buildings for just keeping possession in those rented buildings for the period of 6 months from July to Dec. Anyway, we will once again negotiate with them on this matter and will sort out the issue locally. If we have to pay some money, we will bear the expenses from our organizational reserve fund. We won't mind to delete this line-item from our proposed budget.

4. What will be the budget when the children go back to school? We are trying to compare the budget covering July 2020 to Dec 2020 vs July 2020 to Mar 2021. Will the budgets be significantly different? Which budget line items will be impacted?

Before we discuss in regard to budget and compare the budget covering the period from 'July 2020 to Dec 2020' vs 'July 2020 to Mar 2021', it is next to impossible to make any budget planning unless we can take a policy decision as to when our schools will be reopened.

Situation here is very confusing to take a concrete decision for everyone to open schools. Various types of suggestions and advices are coming from various corners and Government authorities are fumbling to take any concrete decision in this regard. Some provisional dates are being announced but nobody can stick to that. However, Government of India has made an announcement to reopen

schools partially in a phased manner. Initially senior students of Class 12 down to 9 will be allowed to come to schools sometimes in October2020 and middle level classes may be in November 2020 and so on. In view of these we presume that pre-primary schools will get clearance to reopen at the last phase, not before December. Under this situation SWIRD has taken a firm decision that we are not going to open our school till December end or to say specifically we will reopen on and from 1st January 2021.

Hence, bases on the above said decision we are giving you two budget- proposals, one budget from 'July 2020 to Dec 2020') and another budget from January to March 2021

Thus we can add the total cost of 6 months and total cost of 3 months to get the total cost of 9 months. Hence you can easily compare the budget of 6 months covering July 2020 to Dec 2020 vs budget of 9 months July 2020 to Mar 2021.

5. Does SWIRD need additional books or materials during the Covid-19 period?

Yes, it would be justified to consider that the little children are studying at home and don't get any opportunity to play with their friends. Little kids of 3-4 years might be suffering from monotony and it is necessary to provide them with some sort of additional attractive materials like educational toys, drawing books and colour pencils etc. so that they can spend some quality time with those materials to play and learn. We understand that giving toys to 400 children will be highly expensive. Therefore we propose to give them drawing books and colour pencils. This line item has been added in the budget given above for the period, 'July 2020 to Dec 2020' (Six months).
